# **Privacy Policy**

This Privacy Policy (hereinafter referred to as the **"Policy"**) sets out the privacy conditions of the sites proxy-man.com; proxy-man.ru (hereinafter referred to as the "Site").

This Policy is drawn up to explain the use of your personal data: how PROXY-MAN receives, uses, processes, transfers and/or discloses your personal data. By using the Site, you agree to provide and use information in accordance with this Policy.

PROXY-MAN stores, processes and transmits only the personal data that is necessary for the purposes set out below.

PROXY-MAN receives personal data entirely by legal means and receives the consent of the person concerned to process such information, if necessary.

Personal data must meet the purposes of its processing. The data must be accurate, complete and up-to-date to the extent necessary to achieve the goals of processing. PROXY-MAN takes the necessary measures and/or ensures that they are taken to delete or clarify incomplete or inaccurate data.

PROXY-MAN takes all reasonable security measures to protect your personal information from leakage, loss or theft, as well as from unauthorized access, disclosure, copying, use or modification.

## **Your Privacy**

PROXY-MAN complies with all the requirements regarding the protection of your privacy. This Privacy Policy constitutes a document that explains how PROXY-MAN receives your information, how it is processed, and how you can restrict the use of your personal information. The User (the subject of personal data) independently decides on the providing of his personal data and gives consent freely, of his own free will and in his own interest. PROXY-MAN uses the personal data provided by the User in accordance with this Policy. If you provide personal data for certain purposes, PROXY-MAN uses such data for relevant/similar purposes. For example, the personal data received by PROXY-MAN when creating a User account can be used to recommend products similar to those you purchased earlier. Also, your personal data is used to provide access to the services on the Site and to control the providing of services to you. PROXY-MAN may also use the personal data provided by the User and other information obtained when you use the Site, in order to improve the content and features of the Site, better understand users and improve the service.

### **Definition**

For the purposes of this Policy, the following terms are used:

**User** – any visitor to the website proxy-man.com

**Personal data** – any information related directly or indirectly to a specific or identifiable User of the Site.

**Depersonalization** of personal data – action, resulting in the impossibility to determine the identity of personal data to a specific User or other subject of personal data without the use of additional information

#### **Technical information**

PROXY-MAN automatically receives some information when you visit the Site. This information includes the type of device you are using (possibly including unique device identification numbers for some beta versions of the mobile app); the type and version, language preferences of your browser; the type and version of your device's operating system; in some cases, the name of your Internet service provider or mobile operator; the website from which you were redirected to our Site, which pages you request and visit, as well as the date and time of each request made by you on the Site.

This information is used to improve User experience with the Site. For example, PROXY-MAN uses this information to manage websites; provide greater security; optimize mobile applications; customize content and language preferences; test features and improve performance; understand how users interact with the Site; track and study the use of various features, gain an understanding of demographic characteristics and analyze trends. This information is impersonal.

When you visit the Site, we automatically receive the IP address of the device (or proxy server) that you use to access the Internet, which can be used to determine your geographical location.

**Personal identification data** includes information provided by you, such as: name, email address and other relevant information.

You can restrict the amount of information providing to PROXY-MAN when using the Site. If you visit the Site in order to become familiar with its content, as a visitor, you do not need to provide any personal information.

#### **Cookies**

The Site uses cookies to identify the sections of the Site that you have visited. A cookie is a small part of data that is sent by a web server and stored on the User's computer or mobile device.

Cookies are used to personalize what you see on the Site. You can disable cookies in most web browsers. However, if you disable cookies, you will not be able to properly use or access the functions of the Site generally. Personal data is not stored in cookies.

#### Log data

Like many websites, PROXY-MAN collects information sent by your browser when you visit the Site. The log data may contain the following information: computer IP address, browser type, browser version, pages visited on the Site, time and date of visit, time spent on these pages, and other statistics.

### Use of your data

The information that PROXY-MAN receives from you is used as follows:

#### To access the Site

The main purpose of processing personal information is to provide the User with access to the services, information and/or materials contained on the Site.

#### To inform

PROXY-MAN has the right to inform the User by sending emails, as well as to send notifications about various events, special offers and relevant updates.

#### To manage the Site

PROXY-MAN may use the personal data you provide and any device information to customize the Site.

#### Your information and third parties

PROXY-MAN does not provide your personal information to third parties, except cases when it is required by law. We may share your personal information with affiliates (for example, payment systems, hosting companies, etc.) that provide services related to the Site; such affiliates will receive only the information necessary to provide the relevant services and they will be subject to non-disclosure agreements that restrict the use of such information.

#### **Data Aggregation**

PROXY-MAN reserves the right to collect and use any data that is depersonalized and received when using the Site, and use this data for internal research in order to improve the Site, as well as for use or resale to third parties. Such data does not contain your personal information.

#### Storage of personal data

The storage of personal data is carried out in a form that allows to determine the subject of personal data, but no longer than the purposes of personal data processing require, unless the period of personal data storage is established by law/contract, to which the

subject of personal data stands as a party, beneficiary or warrantor. The processed personal data will be destroyed or depersonalized upon achievement of the goals, unless otherwise provided by law.

#### Data disclosure in conformity with the law

Disclosure of personal information is carried out by PROXY-MAN in conformity with law, if one or more of the following grounds are present:

- a) a subpoena or other official request from appropriate authorities requires us to disclose personal information;
- b) assistance to law enforcement officers is required to investigate offenses;
- c) other provision of PROXY-MAN services in accordance with the law;
- d) the need to protect PROXY-MAN from litigation or claims from customers and third parties;
- e) protection of legal rights of our users, employees and branches, partners, real estate.

Processing of **special** categories of personal data related to race, nationality, political views, religious or philosophical beliefs, intimate life is not **carried out** by PROXY-MAN.

## Third-party sites

The Site may contain links to third-party sites that are not controlled by PROXY-MAN and/or its affiliates. Such sites should have their own privacy policies. PROXY-MAN is not responsible for your interaction with any of these sites and provides links to them merely for the convenience of visitors and for the providing of additional information. You should read privacy policy of any website, if any, in order to learn how your personal data will be used by different websites.

All information received by third-party services, including payment systems, communication facilities and other service providers, is stored and processed by these services in accordance with their User Agreement and Privacy Policy. The subject of personal data and/or the User must familiarize themselves with these documents in reasonable term. PROXY-MAN is not responsible for the actions of third parties, including the service providers described above.

## Security

We consider the security of your personal data to be a matter of vital importance. However, you must remember that the method of transmitting or storing information on the Internet cannot be 100% secure. Although PROXY-MAN uses every effort to protect your personal data by all reasonable, commercially acceptable means, its absolute

security cannot be guaranteed. PROXY-MAN takes measures to protect your personal data from leakage, loss, abuse, alteration, etc. Personal data is stored in a secure database and is always sent through encrypted SSL, if it is supported by your browser. No data transmission through the network or e-mail can be fully protected, and there are no guarantees of error-free transmission. You should be careful when determining what information will be sent by email.

### **Policy Update**

PROXY-MAN reserves the right to change the Policy at any time. The User is obliged to read the current Policy and accept its provisions. If some significant changes are made to this Policy, the User will receive a notification in a blog on the Website or by e-mail, or by any other means. The choice of the method is at our discretion. The date of the "last update" at the beginning of this Privacy Policy will also be changed. Any changes that PROXY-MAN makes to this Privacy Policy come into effect from the moment it is published on the Website and completely replace all previous related documents.
